Dear Myriam,

Just wanting to fill you in on my experience to date with the Recovery Consulting Programme that I purchased from you on August 20, 2007.

I have found that generally if I qualify them at the initial contact and they express interest, the probability that they come on board is very high.

I must admit that I was unprepared for the amount of paperwork involved but with careful organisation and planning this is all under control now.

It was a little frustrating at first ( not everyone is easy to deal with) but I can see that the results will certainly be there. I feel my initial results in such a short time have shown that to be true.
